Operation Encompass

I have attached for you an up-to-date Operation Encompass log sheet for you to print out and have ready to complete if you are called with a notification.



Operation Encompass

Thank you for continuing to work in partnership with Merseyside Police to improve the Operation Encompass process in Merseyside.

The purpose of an Operation Encompass notification is to provide you with an insight into the lived experience of a child, so that you can understand any change in behaviours and support the child or young person when they are in your setting or school.

You should never telephone or approach the victim about the notification as you may place them in a position of additional risk.

Through the promotion of your involvement in Operation Encompass (website, posters, letter to parents), parents will be aware that you receive notifications and approach you to discuss if they feel comfortable and safe to do so.

You will continue to receive notifications throughout the school holidays. You are not expected to contact the child or parent. This is for your knowledge for when the child returns to school.

The Police will make any necessary referrals to partners, separate to the Op Encompass process.

We are continually trying to improve the Operation Encompass process in Merseyside and want to work together to provide a better tomorrow for our children impacted by Domestic Abuse.

Below are some key points that will hopefully assist you.

- If you need to update any contact details or receive a notification in error, please contact us at operation.encompass@merseyside.police.uk.
- If you are having issues accessing an Operation Encompass notification, please make sure you;
 - 1. Open the notification from an email account the notification was originally sent to.
 - 2. Use an Egress account matching the email address in point 1.

If you do not carry out the above steps, you will not be able to access the notification.

- All Dedicated Safeguarding Leads and the Safeguarding Governor are expected to complete the online Operation Encompass training which can be found here <u>Online Key Adult Training</u>: <u>Operation Encompass</u>
- If you require any support/advice regarding an Operation Encompass notification, please contact the Operation Encompass Teachers' Helpline. It is available for all education staff to speak in confidence with an educational or clinical psychologist about how best to support children in their setting who may be experiencing domestic abuse.

The Helpline is available on **0204 513 9990** and is open from 8am to 1pm, Monday to Friday, term-time. Please note that calling the helpline should not replace statutory safeguarding processes.
