#### Introduction

This document provides an overview of the spatial distribution of housing land supply from 2016-2037. Included within Appendix 1 is a table that outlines on a ward-by-ward basis the following information:

- Net completions from 1 April 2016 to 31 March 2021;
- Dwellings under construction as at 31 March 2021;
- Current commitments (as at 31 March 2021);
- SHLAA sites without planning permission; and,
- Proposed sites allocations.

Please note that for the columns titled: Sites Under Construction, Committed Sites and SHLAA sites without Planning Permission, only sites delivering 5 units or more or above 0.25ha are included.

Additionally, two historically stalled sites have been included within the 'sites under construction' column.
