 or removal without further notice.
- The Authority cannot accept liability for loss of, or damage to, any Memorial, floral tribute or other article which may be fixed or placed within the Memorial Garden, however such loss or damage may be sustained
- 4. The period of lease allowing a plaque shall expire on the tenth anniversary of the date it was issued. A reminder notice will be sent to the last registered address of the owner one month prior to the expiry date
- A maximum of 4 lines of inscription are possible on each single plaque.
 The total number of letters (incl. Spaces) not to exceed 70
- A maximum of 8 lines are possible on each double plaque The total number of letters (incl. Spaces) not to exceed 140.
- 7. No line of inscription may contain more than **26** letters (incl. spaces)
- 8. No inscription may be added to a name line
- The Authority retains the right to amend or refuse any inscription as may Be considered inappropriate.
