#### NEW Early Years Foundation Stage valid from January 2024- PUBLISHED

There are two versions of the EYFS document, one for childminders and another for the nurseries and schools. Department for Education is referring to the private settings no as PVIs (Private, Voluntary, Independent) but as a group- based provider, similar to schools as school-based providers.





From 4 January, 2 revised frameworks will replace the current EYFS framework.

Providers are responsible for ensuring that they follow the current version of the framework for their provider type.

The 2 new frameworks are:

- EYFS statutory framework for childminders
- EYFS statutory framework for group and school-based providers

The EYFS framework also includes Early years qualification requirements and standards.
