Bond or Surety

As part of the agreement the developer will be required to deposit a cash or surety bond with St Helens Borough Council to cover the cost of the highway works. This bond ensures that St Helens Borough Council does not incur any costs if the highway works are stalled, changed or aborted by the developer.

The bond or surety figure will be calculated by St Helens Borough Council upon completion of the technical approval process. The bond value of adoptable works does not include fees, charges or commuted sums.

The works detailed within the Section 278 Agreement will be staged and following completion of each stage, the developer will receive the relevant certificate and there will be a reduction in the value of the surety's obligation.

Payments

St Helens Borough Council will charge a fee for the design checks and supervision of the highway works. This fee is currently 10% of the estimated highway works costs that are based upon the developer's priced bill of quantities that will need to be submitted once the design has obtained full highway authority approval. Should any statutory undertakers equipment be effected by the modification of the highway works then an additional fee of 4% will be charge that will be calculated using the developers diversion (C4) costs.

Once the s278 agreement has been signed by all parties the design checks, supervision fees and any commuted sums must be paid without delay prior to any works commencing on site.

Please ensure you have obtained a payment reference prior to making any payments and quote this on all payments / correspondence.
